LIMIT OF LIABILITY:

a) Employers' Liability	unlimited or £10,000,000
b) Public Liability	£10,000,000 any one occurrence / unlimited any one period of insurance.
c) Products' Liability	£10,000,000 any one period of insurance.

SITUATION: Any premises owned or occupied by the Insured and elsewhere in the United Kingdom.

CONDITIONS/ CLAUSES:

- * Maximum working height - unrestricted
- * Policy excess is £10,000 each and every loss including Third Party Injury
- * Excluding work on airports, water craft, dams, jetties, mines and off shore and erection of Spectator Stands and other Hazardous Locations. (These may be included by agreement with underwriters).
- * Bona Fides Sub-Contractors' Clause

EXTENSIONS:

a)	Policy can be extended to work on demolition site in regard to erection and dismantling of Scaffolding.
b)	Policy is extended to include work which may be on site where there is 'non-notifiable' asbestos, i.e. asbestos sheet roofing.
c)	Policy includes all areas where scaffolding foundation may be sited near the water, but not in the water, such as buildings in Dockland, which may be adjacent to water.
